

2016 Highlights

This is our final newsletter of 2016 before we issue our annual report. As we close out the year, we thought it would be appropriate to look back at some key moments in 2016.

- **January**—Larry Gregory appointed to the AGA Board; MS Attorney General issued opinion that fantasy sports is illegal under current Mississippi law.
- **February**—MGHA launched social media campaign for SGS led by J.Carcamo & Associates; IP Casino donated \$1 million to Coast Non-Profits; Tony Scudiero named VP & GM of rebranded Vicksburg casino (Waterview Casino & Hotel); Caesars added 5,000 rooms to renovation program (including its MS casinos)
- March—Justin Carter named VP & GM of Penn National's Hollywood Casino in Tunica; Palace Casino in Biloxi won 9 Best of Dining Awards; 1stQ ended with GGR up 6.4% on Gulf Coast; down 2.6% in the River Counties; up 2.2% statewide.
- April—HB 1074/SB 2964 passed creating the Economic Infrastructure Fund (EDI Fund), including \$2.5 million appropriated to incentivize new air service; SB 2541 passed making daily fantasy sports (DFS) legal in Mississippi until at least July 2017; restocked historical tax credits gave new life to restoration projects in Mississippi.
- May—Waterview Hotel & Casino held grand opening in Vicksburg; Harrah's Gulf Coast ribbon cutting marked renovations and redesign of 494 rooms; Hard Rock won top trip advisor award; Southern Gaming Summit brought over 2,000 visitors to Gulf Coast marked with keynote speaker Anthony Sanfilippo, excellent educational sessions and top notch speakers, as well as daytime and evening events at Island View, Hard Rock, Golden Nugget, and Harrah's Gulf Coast's Grand Bear golf course.
- June—Margaritaville Resort (a non-gaming facility) opened its doors in Biloxi to summer crowds; Harrah's Gulf Coast broke ground on Blind Tiger Restaurant; 2Q ended with GGR up 4.7% on Gulf Coast; down 3.2% in the River Counties; up 1% statewide.

2016 Highlights — Continued

- July—Caesars Entertainment's—Horseshow Tunica unveiled 192 newly renovated rooms as part of its overall 5,000 room renovation program; Kiplinger Personal Finance ranked MS as the 6th most tax friendly state; Governor called special session to obtain authority to draw down \$110 mm from Rainy Day Fund to meet budget; MS legislators announced plans to form 'working groups' to study spending and make recommendations to Legislature in 2017 session.
- August—Roscoe Greene appointed President & GM of Harlow's Casino Resort in Greenville; AGA held roundtable / press conference before crowd of 100 onlookers at IP Casino in Biloxi as part of its Get to Know Gaming campaign; Uber arrived in MS; Horseshoe Tunica opened its Asian Bistro (Lucky 8); Craig Ray appointed to lead MDA Tourism office; US Court of Appeals for 3rd Circuit voted 10-2 to hold that NJ's 2014 sports-betting law violated PASPA
- September—MGHA rolled out its MGHA Responsible Gaming program—approved and certified by the MGC; MGHA worked closely with MDA to draft guidelines for new Air Incentive Program; Allen Godfrey honored by IMGL as Regulator of the Year for North America; Victoryland reopened in AL; Isle of Capri announced sale of assets to El Dorado Gold for \$1.7billion; 3Q ended with GGR up 4.1% on Gulf Coast; down 2.7% in the River Counties; up 1% statewide.
- October—Tropicana Entertainment announced the appointment of John Phillipp as GM for Trop Casino Greenville; MGC asked for public comments to proposed changes to MGC Rule 1.4 drawing strong opposition; Lyle Berman (Miss. Gaming Pioneer) admitted to Gaming Hall of Fame; MGC decides not to change regulations; Cruisin' the Coast draws record crowds (over 8,500 registered cars); Hard Rock opens Macau Kitchen and new gaming space-Fortune Palace.
- November—MDA Air Incentive Guidelines became effective as of Nov. 24; Mississippi and four other states filed briefs
 with US Supreme Court to argue PASPA unconstitutional; Louisiana creates Riverboat Economic Development &
 Gaming Task Force to consider revamping gaming laws; Alabama appoints members to advisory council on gaming;
 Donald Trump elected President of the United States.
- **December** —inaugural Mississippi Gulf Coast Marathon draws over 3,300 runners; Federal judge enjoins implementation of new FLSA regulations on overtime; IRS drops burdensome gaming proposals, including proposal to lower jackpot reporting; columnist Rudi Schiffer honored for 25 years of work in gaming and has last radio broadcast; 4Q projected to end with GGR up over 4% on Gulf Coast; down 2.7% in the River Counties; up 1% statewide.



AGA Outlines Priorities to President-elect Trump



The gaming industry appears hopeful that a president with gaming experience will improve the outlook for the

industry. In a memo the American Gaming Association recently sent to President-elect Trump's transition team, it outlined gaming's impact on our country and the its priorities as the administration moves forward.

Key highlights:

- Gaming is a \$240 billion industry
- Gaming supports 1.7 million American jobs in 40 states
- Gaming generates \$38 billion in annual tax revenue
- In the next decade, the gaming industry is expected to add more than 62,000 direct jobs
- Gaming employs workers in more than 200 different job classifications

 45% of the gaming workforce is composed of racial or ethnic minorities, compared to the national average of 33%

AGA priorities include:

- Illegal Gaming—eliminate illegal sports betting, black market machines, internet sweepstakes cafes, animal fighting, and illegal online betting.
- Sports Betting—legalize and regulate what is now a \$150 billion per year illegal industry.
- Anti-Money Laundering Compliance—Continue the gaming industry's strong efforts to combat money laundering and terrorist financing.
